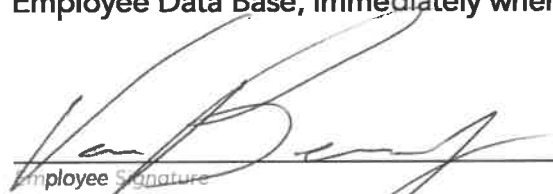

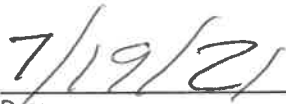


Competency Assessment - Direct Care Staff
