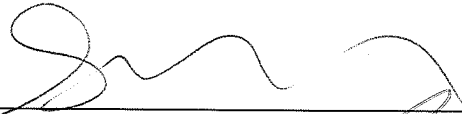

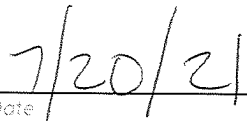
Competency Assessment - Direct Care Staff

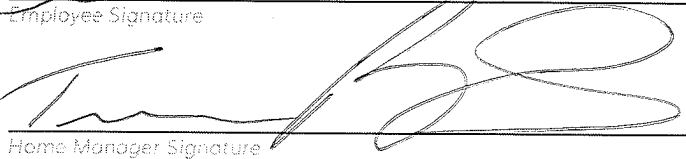
Both the Orientation Checklist and the Competency Assessment are to be uploaded into Employee Data Base, immediately when complete.
