





Expectations

- **Dress Code (64)**
 - Simulation Center is a **clinical area.**
 - Clinical attire **is expected.**

Expectations

- **Behavioral Congruence (39)**

- **HONOR CODE (41)**

- Students and faculty are expected to report to the Dean (or the designee) the conduct that violates the standards of professional honesty and integrity. It is the intent of this policy to support an atmosphere of integrity within the Covenant School of Nursing.

Expectations

- **HONOR CODE (41)**

- It is the responsibility of each student to support this atmosphere both individually and collectively. We expect nursing students to enter the program knowing what is right and what is wrong. Nursing ***students are expected to do what is right*** when it comes to matters of ***integrity***, ***honesty***, and ***ethical conduct***. Further we expect nursing students to move beyond thinking only of their own situations to thinking of what is right for their peers, their patients, and ultimately the nursing profession.

Expectations

- **HONOR CODE (41)**
- **A violation of the Honor Code may lead to disciplinary action up to and including dismissal or expulsion.**

Expectations

- **Cell Phone Use (56)**
 - Texting/socializing is inappropriate during class time. If texting/ socializing occurs and is disruptive to faculty or students, privileges of cellular phone usage of any kind will be revoked.
 - **Abuse** of cellular phone usage **will result in disciplinary action** up to and including dismissal/expulsion. This policy includes any device that is internet capable.

Expectations

- **Confidentiality (57)**
 - Refer to your signed confidentiality statement

Expectations

• **Audio/Video**

- Confidentiality will be maintained in the Simulation Center setting.

- Students are not to discuss or provide, by any means, the scenario content with colleagues that have not attended/participated in **ANY** simulation clinical.

- Any audio or video recording or still photographs while in the simulation center must be approved by the instructor and the Simulation Coordinator.

- **Performance**

- You should be at the Simulation Center with the goal of acquiring and/or practicing nursing skills

Expectations

- **Student Responsibilities**
 - **Noise levels**
 - Liquids near manikins/computers
 - Soiled linen
 - Supplies
 - Moving manikins
 - Please report any broken equipment as soon as possible.

Expectations

• **Student Responsibilities**

- Bring reference materials as needed
- Badge in and out each time you are at the Simulation Center. (*more later*)
- Be actively engaged
- NO food or drink is allowed in any patient care area.
- Be respectful of other groups (noise)
- Clean-up of the rooms
 - End of day trash
 - 'Patient' positioning
- RESPECT THE SPACE

COVID-19 Modifications

- Masks at all times- cloth masks are ok
- Social distance when able.
- Limit close proximity
- Hand hygiene frequently
- Clean surfaces frequently
 - Cleaning solutions provided
 - Ask which solution to use on which equipment
 - If in doubt, ASK, then clean it.

Guidelines

- **Refrigerator**

Guidelines

- **Lockers**

Guidelines

- Deliberate Practice

- a **highly structured** activity engaged in with the **specific goal** of improving performance
- is different from work, play and simple repetition of a task
- **requires effort**
- has no monetary reward
- may **not be inherently enjoyable**

Guidelines

- **Components:**
 - Given a **task** with a **well defined goal**
 - **Motivation** to improve
 - Provided with **FEEDBACK**
 - Provided ample **opportunities for repetition**


CODE Fire

- **Students**
 - If you discover a fire: (**RACER**)
 - **R**escue/remove anyone for immediate danger
 - **A**ctivate the alarm
 - Pull the Fire Alarm
 - Call emergency #
 - 44444 (in house phone)
 - 806-725-CODE (2633) on cell phone
 - **C**ontain the Fire
 - Close ALL DOORS
 - **E**xtinguish the fire OR **E**vacuate the premises
 - proceed to the nearest fire exit and exit the building
 - **RALLY POINT**
 - first floor of the parking garage for attendance check

First one to discover shooter

- ***CALL and give situation/location***
 - ***911 (in-house phone/cell)***
 - ***44444 (in-house)***
- ***OR***
 - ***806-725- CODE (2633) (cell)***

Active Shooter- Announced overhead

- Announced overhead
- Evacuate (IF SAFE TO DO SO)
- **Students**
- **Faculty**

Active Shooter-

Active shooter is in your area

- Try to remain calm
- Don't provoke the shooter
- IF YOUR LIFE IS IN IMMINENT DANGER
 - You may need to choose to:
 - Try to negotiate OR
 - Over power the shooter

Active Shooter-

Away from immediate threat

- **Try to remain calm**
- **Warn others to:**
- **Evacuate if possible OR**
- **Take shelter**
- **Lock doors**
- **Barricade in**
- **Turn off lights**
- **Close blinds/block windows**

Active Shooter-

Away from immediate threat

- **SILENCE PHONES**
- **CALL**
 - 911 and
 - 806-725- CODE (2633) (cell)
 - "COVENANT CHILDRENS HOSPITAL, 5 NORTH, ACTIVE SHOOTER, SHOTS FIRED"
