

IM7 Pharmacology Presentation

Each student will be responsible for presenting a medication to their peers via a Teams meeting. The number to the left of your name on the clinical schedule is the medication number assigned to you. ** See the image below for a reference. **

Review the attached grading rubric prior to presenting, your presentation will be 5% of your total module grade to be added once you achieve an average of 75 or higher on module exam grades.

Presentation requirements are as follows:

1. Presentation must be kept to 5 minutes or less.
2. A visual aid must be used to aid the presentation. If PowerPoint is your visual aid of choice, keep slide count to no more than 6 slides.
3. Information on medication must include:
 - Drug classification
 - Medication uses
 - Signs & symptoms unique to assigned medication & any black box warnings
 - Nursing implications - what to assess and monitor (precautions too)
 - Patient teaching about medication including diet considerations if applicable
4. Write a test question over assigned medication in any format other than True/False format. At the end of assigned presentation time, have peers answer the question.
