Learning to be a reflective practitioner includes not only acquiring knowledge and skills, but also the ability to establish a link between theory and practice, providing a rationale for actions. Reflective practice is the link between theory and practice and a powerful means of using theory to inform practice thus promoting evidence based practice.” (Tsingos et al., 2014)

Using the Reflective Practice template, document each step. The suggestions in the boxes may help you as you reflect on the incident. This Reflective Practice document will be reviewed by faculty and then you will post the final reflection in your LiveBinder folder.

<p>Step 1 Description A description of the incident, with relevant details. Remember to <u>maintain patient confidentiality</u>. Don't make judgments yet or try to draw conclusions; simply describe the events and the key players. Set the scene! It might be useful to ask yourself the following questions</p> <ul style="list-style-type: none"> • What happened? • When did it happen? • Where were you? • Who was involved? • What were you doing? • What role did you play? • What roles did others play? • What was the result? 	<p>Step 4 Analysis</p> <ul style="list-style-type: none"> • What can you apply to this situation from your previous knowledge, studies or research? • What recent evidence is in the literature surrounding this situation, if any? • Which theories or bodies of knowledge are relevant to the situation – and in what ways? • What broader issues arise from this event? • What sense can you make of the situation? • What was really going on? • Were other people's experiences similar or different in important ways? • What is the impact of different perspectives eg. personnel / patients / colleagues?
<p>Step 2 Feelings Don't move on to analyzing these yet, simply describe them.</p> <ul style="list-style-type: none"> • How were you feeling at the beginning? • What were you thinking at the time? • How did the event make you feel? • What did the words or actions of others make you think? • How did this make you feel? • How did you feel about the final outcome? • What is the most important emotion or feeling you have about the incident? • Why is this the most important feeling? 	<p>Step 5 Conclusion</p> <ul style="list-style-type: none"> • How could you have made the situation better? • How could others have made the situation better? • What could you have done differently? • What have you learned from this event?
<p>Step 3 Evaluation</p> <ul style="list-style-type: none"> • What was good about the event? • What was bad? • What was easy? • What was difficult? • What went well? • What did you do well? • What did others do well? • Did you expect a different outcome? If so, why? • What went wrong, or not as expected? Why? • How did you contribute? 	<p>Step 6 Action Plan</p> <ul style="list-style-type: none"> • What do you think overall about this situation? • What conclusions can you draw? How do you justify these? • With hindsight, would you do something differently next time and why? • How can you use the lessons learned from this event in future? • Can you apply these learnings to other events? • What has this taught you about professional practice about yourself? • How will you use this experience to further improve your practice in the future?

<p>Step 1 Description During our admin of morning medications our patient reported a pain of 9 with a throbbing sharp migraine pain. My patient requested to take morphine for the pain and a migraine.</p>	<p>Step 4 Analysis I can apply to later situations that education of your patient even when they don't want to hear it is important and should be done every time with medication admin. I can also apply the pharmacokinetics and ADR of morphine to this situation.</p>
<p>Step 2 Feelings At first I thought, sure that would work for the pain and didn't think that should be a problem until my nurse explained that morphine's major side effect is rebound head ache and the half life of morphine is very short and would only help for a little bit and then she would have to wait in pain longer till her next pain med was ready.</p>	<p>Step 5 Conclusion I have learned that education is important and should be done to protect the patient and avoid harmful situations. Something that I can do different is commit ADR of medications that are frequently used to memory.</p>
<p>Step 3 Evaluation At first the patient was agitated that my nurse explained that it wouldn't be very helpful but then after education she understood and was satisfied with a different pain medication.</p>	<p>Step 6 Action Plan Overall it is important to inform the patient of medications and be aware of the ADR to give the best care to your patient. I can apply this situation to every drug administration to ensure the safety and satisfaction of my future patients.</p>
