**Case must be:**

- Registered Nurse
- Involves charges related to patient care IN A HOSPITAL OR CLINIC SETTING (med errors, patient safety, drug diversion, patient abandonment, etc.)

**Case may not be:**

- LVN, NP, APRN, etc.
- Cases that do not directly impact patient care (instances during personal life, occurrences outside hospital or clinic work hours, charges for not paying student loans, etc.)
