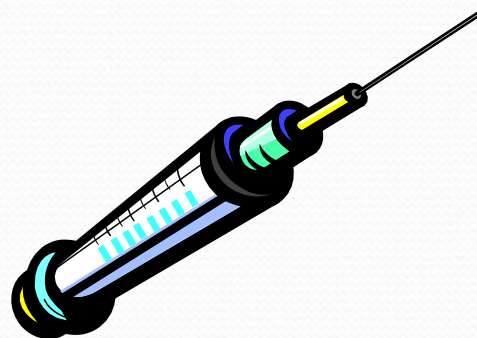
- Health assessments

Immunizations

- Condition of school entrance requirements.
- Start necessary immunization before the first day of school.
- Students must have a Respirator Fit test at the end of Module 4 before beginning Module 5.

- First aid



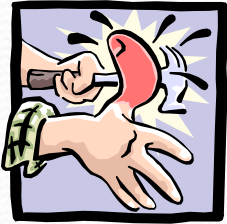
- Over the counter medicine

What do you Report to CHS?

- Work/School-related injuries/illnesses
- Personal: Injuries/illnesses
- Exposures: Biological, Chemical and Environmental
- Rashes
- Latex allergy
- Work/school acquired infections

Work Related Injury Occupational Exposure



- Report immediately to EHS.
- Inform your instructor/faculty staff member of the incident.
- Recommend to have personal health coverage insurance.
- If incident occurs outside normal business hours notify the On-call nurse Immediately.
- This individual will work with you on what to do next.

Exposures Management

- Wash the site immediately with soap and water
- Report immediately to CHS and or the On-call Nurse
- Identify and document source patient
- Lab work, Counseling, and monitoring
- Results are kept confidential
- Follow up
- Utilize safe devices effectively

COVID

- If a student is positive with Covid-19, exposed to a positive Covid-19 person or has symptoms of Covid-19

they must follow the steps below:

- Notify their current faculty immediately.
- CSON Leadership will contact the student and notify them of next steps.
- All students will follow Covenant Health protocols
- Students should not come to school or clinical if they are ill and have a fever

Respiratory Mask FIT

- A respiratory mask and FIT test are required (by OSHA) for Covenant employees/students who provide direct patient care, whose position brings them in direct patient contact, and/or who are at risk for exposure to various infections.
- Note: Employees/students who have facial hair that interfere with the respiratory mask will not be FIT tested until the facial hair is removed. (Reformed OSHA #1910.132 and 1910.134)

Drug Free Environment

- Reporting to school/work while under the influence of alcohol, controlled substance/illegal drugs, and/or possessing, consuming, or using alcoholic beverages, controlled substances and/or illegal drugs, as well as the unlawful use of inhalants while on Covenant premises is strictly prohibited.



Reasonable Cause

- Abnormal/erratic behavior
- Information from reliable source
- Direct observation
- Breath, slurred speech, glassy eyes, poor coordination
- Access to drugs: errors, missing narcotics

Refusal to Consent

- Applicant/Student: disqualified from further consideration for school or employment
- Reasonable Cause: termination from school or work

Reasonable Cause

- Suspended pending results
- Positive for illegal/controlled drugs: without a prescription- termination from school

Student Health Records

- Students Health records will be maintained in Caregiver Health Services
- Upon graduation, students should obtain their records from Caregiver Health.
