During the day I got to observe a transabdominal and transvaginal ultrasound for the first time! I also got to help participate with a patient's pregnancy test and got to be there when the nurse told them they were pregnant!

Yes! They do ultrasounds, std testing, pregnancy testing, counseling & parenting classes. I feel like this place is a very good place to go to when needing help on finding resources for prenatal care. The clinic was very welcoming and all of the staff were so sweet. The nurses were so good on educating the patients and helping them to know where to go after finding out your pregnant and needing help!

5. Did you witness patient teaching? What general things were taught to this population? Do you feel that patient teaching in this community site was adequate? Why or why not? There were only 2 patients during the time I was there, but I heard A LOT of patient teaching just from those two scenarios. There was a lot of teachings on how to get Medicaid for during pregnancy and the steps and paperwork for that. There were teachings on signs of miscarriage vs normal vagina bleeding and cramps during pregnancy, and when you should go to the ER. There were papers and brochures for lab testing centers, and OB doctors that these patients could get in contact with. The nurse also was very good about showing and helping the patient understand the ultrasound. This site was very on top of all of their teachings and a very good place for the community.
