Location: Covenant Medical Office Building, 4102 24th Street, Suite #300 (3rd Floor of green glass building across from lake).

Where to Park: Parking Garage off of 22nd Place & Peoria (across from Joe Arrington Cancer Center). Park in the garage and walk across the sky bridge. Take the Elevator to the 3rd floor inside the building. The parking garage is free.
