


Purchasing Process for Crown's Budget Coaching Course

Once you have registered for the course, you will receive a Welcome call. During this call, you will be asked to provide some basic information, such as whether you will be going through the course alone or with someone, such as a spouse, fiancée/fiancé or mentor, if you have any preferences for a coach (such as male or female), and what time zone you reside in.

Coach assignments are typically made within 2 business days if coaches are available. If there is a backlog of client requests, you will be notified during the Welcome call.
