DIRECTIONS FOR USE:

Each week the students evaluate themselves based on the competencies using the performance code on page 2. The performance code includes the terms **Satisfactory (S), Needs Improvement (NI), Unsatisfactory (U), and Not Available (NA)**. The faculty member will initial if in agreement with the student’s evaluation. If there is a discrepancy in the performance code evaluation between the student and the faculty member, a note is written in the comment section by the faculty member with the rationale for the evaluation. All competencies must be rated a “S, NI, U, or NA”. If the student does not self-rate, then it is an automatic “U”. A student who submits the clinical evaluation tool late will be rated as “U” in the appropriate competency(s) for that clinical week. Whenever a student receives a “U” in a competency, it must be addressed with a comment as to why it is no longer a “U” the following week. If the student does not state why the “U” is corrected, it will be another “U” until the student addresses it. All clinical competencies are critical to meeting the objectives of the course. If the final performance code is unsatisfactory or needs improvement in any one of the competencies, a grade of unsatisfactory is given. If a pattern of unsatisfactory performance occurs after performing the competency satisfactorily, this also constitutes a grade of unsatisfactory. An unsatisfactory or needs improvement as a final score in any single competency results in a clinical course grade of unsatisfactory; this is a failure of the course. The terms Satisfactory and Unsatisfactory will be used in evaluating the final grade or clinical course performance.

Needs Improvement (NI): Safe, accurate each time, skillful in parts of behavior, focuses more on the skill and self rather than the patient, inefficient, uncoordinated, anxious, worried, and flustered at times, expends excess energy within a delayed time period, frequent verbal and occasional physical directive cues in addition to supportive cues, faculty feedback required in several areas of clinical written work.

Unsatisfactory (U): Failure to achieve the course competency, safe but needs faculty reminders constantly, not always accurate, unskilled, inefficient, considerable expenditure of excess energy, anxious, disruptive or omitting behaviors, focus on skills and/or self, continuous verbal and frequent physical cues, unsafe, performs at risk to patient/clients/others, unable to function, incomplete, erroneous, faulty, illegible clinical written work, no feedback sought from faculty or response to feedback not evident in submitted written work. If the student does not self-rate a competency the competency is graded "U." A "U" in a competency must be addressed in writing by the student in the Evaluation of Clinical Performance tool. The student response must include how the competency has been or will be met at a satisfactory level. If the student does not address the "U", the faculty member (s) will continue to rate the competency unsatisfactory.

would include the author(s) last name(s) and publishing year as the in-text citation. For example, following the information that came from the resource, you would put (Potter et al., 2019). We certainly don't mark off for incorrect APA formatting, but will provide some guidance along the way for accuracy. Purdue OWL for APA formatting is an excellent resource to refer to. Also, don't ever hesitate to reach out for clarification. Great job! NS

Week 9(4c,f): You did a good job accessing medical information on your patient in Meditech. Competency 4f was changed to a "NI" because you did not include an in-text citation in your peer response, although all other requirements were met. CB

In addition, your patient was experiencing pain and nausea, making communication even more challenging. However, you took the opportunity to provide comfort and demonstrate your desire to learn more about him. As mentioned above, you learned a great deal about your patient in a short period of time. Well-done! NS**
- b. Week 7: I will grow in the area of giving a head-to-toe assessment through practicing at home on family members three times this week to make sure this becomes second nature to me. **Your comfort and confidence in performing assessment will improve with each experience. The more you practice, the more natural this will become. I think you have a great plan for improvement moving forward. I look forward to seeing you grow throughout the semester. Keep up the hard work! NS**
- c. Week 8: My strength with my patient this week was in understanding that the patient was young at heart. Although my patient was a young 61 year old, I became aware very quickly through conversation and seeing the patient's

If the student does not state why the "U" is corrected, it will be another "U" until the student addresses it. CB

Regarding Week 9 (8a,b): I received a "U" due to the fact that I did not include a comment on reflecting on my strengths and weaknesses because I didn't realize I needed to do it every week because I was not using my brain. In the future clinical experiences & weeks I will document a comment reflecting on things I have improved on and still need work on. **CB**

- a. Week 10: One of my strengths was accessing Meditech to view the patient's history and current situation to figure out that she had protein malnutrition and I made it a point to tell my patient as well as her adult granddaughter the importance of taking in protein to promote healing and strength. My Patient had a more developed form of Alzheimer's than originally stated, so I am aware that she may not remember the education, but her granddaughter is definitely able to understand the importance. **Education is very important, and I am glad that you were able to give your patient and their granddaughter information regarding her protein intake and ways to improve it, great job! CB**
- b. Week 10: I will grow in the area of walking out in the hallways and being available when call lights are going off. I have not done well with this skill because I either haven't heard them or because I am worried I won't be able to help the patient because I don't know their history. **I know that it can be a little scary and nerve-racking not knowing a patient before you answer a call light, but the more that you take the leap and answer a call light, the more comfortable you will become. In addition, if you do not know something about a patient, you can always ask them to hold on a minute, you will find out, and be right back. CB**
- a. Week 12: One of my strengths is paying attention to the other medical staff, such as PT/OT and listening and watching the therapy they are providing and caring it out with my patient even when they aren't there. An example of this was I watched PT the first day with the patient as they explained the importance of her not putting weight on her left foot when ambulating and when getting ready to sit have her left foot out in front of her to assist in avoiding putting that pressure on the left hip/femur. Every time I was with the patient after that, ambulating and even getting ready to sit, I would remind the patient not to put the weight on her left foot. She always would say, "oh that's right". **Melisa, this is a great way to learn and see things from a different perspective. This is why we encourage students to be in the room when other disciplines are working or talking with the patient, because you can gain so much knowledge. CB**
- b. Week 12: I will grow in the area of being less upset with co-workers when I feel they are not performing good teamwork/communication. Just take a breath and be more thoughtful and patient about the situation and understand that everyone has their own way of doing things. **Sometimes things will be difficult and maybe you won't understand another person's reasoning, but taking a breath and a step back to focus on the whole picture of caring for the patient being the most important thing, is a great way to refocus. CB**

During lab this week you were able to satisfactorily demonstrate:

- Appropriate hand hygiene utilizing hand sanitizer and soap/water.
- Accurate verbalization of procedure for donning & doffing PPE.
- Appropriate level of skill during guided practice with measurement of radial and brachial pulses, along with manual blood pressure. Vital signs skills will be observed 1:1 with faculty during Week 3. Keep up the good work! AR

Week 3 (Vital Signs):

Great job in the lab this week! You satisfactorily completed the vital sign check off during 1:1 observation, including oral temperature, radial pulse, respiratory rate, pulse oximetry, and blood pressure measurement. During the blood pressure measurement, you accurately obtained two out of two blood pressure results on the Vital Sim manikin. You were able to verbally discuss the following measurements: axillary and rectal temperature along with orthostatic vital signs. You did remind yourself to verify the patient's identity by asking for the name and DOB and required one prompt as a reminder to assess blood pressure in both arms and then continue to use the arm with the highest systolic pressure when obtaining orthostatic vital signs. One prompt was needed during the insertion, because you placed the Foley bag on the side of the bed prior to securing the catheter to the patient's leg with the StatLock. You also grabbed the catheter prior to cleaning with the povidone iodine swabs, however you caught yourself and did not break sterility. You did also receive one prompt on the removal because you did not empty the drainage bag prior to removing the catheter. You also received a reminder to place a waterproof pad between the patient's legs prior to removal. You had very good communication with your "patient". Great job! You correctly verbalized the differences in catheter insertion for a male patient. Actively participated in the Intake and Output stations, and completed Meditech documentation related to Urinary Catheter Management and Intake & Output. Keep up the great work!!! HS

Week 9 (Dressing Change: Dry Sterile, Damp to Dry Packed, Stoma Skills):

You have demonstrated competence in the skill of wound assessment and wound care through guided observation of Dry Sterile Dressing and 1:1 observation of Damp to Dry Packed Wound Dressing Change. During the Damp to Dry Packed Wound Dressing Change, you were able to recognize potential contamination of the sterile field and discussed how it would be resolved related to pouring saline of the gauze.
