DIRECTIONS FOR USE:

The performance code includes the terms **Satisfactory (S)**, **Needs Improvement (NI)**, **Unsatisfactory (U)**, and **Not Available (NA)**. The faculty member will initial if in agreement with the student's evaluation. If there is a discrepancy in the performance code evaluation between the student and the faculty member, a note is written on the comment section by the faculty member with the rationale for the evaluation. All competencies must be rated a "S, NI, U, or NA". If the student does not self-rate, then it is an automatic "U". A student who submits the clinical evaluation tool late will be rated as "U" in the appropriate competency(s) for that clinical week. Whenever a student receives a "U" in a competency, it must be addressed with a comment as to why it is no longer a "U". If the student does not state why the "U" is corrected, it will be another "U" until the student addresses it. All clinical competencies are critical to meeting the objectives of the course. If the final performance code is unsatisfactory or needs improvement in any one of the competencies, a grade of unsatisfactory is given. If a pattern of unsatisfactory performance occurs after performing the competency satisfactorily, this also constitutes a grade of unsatisfactory. An unsatisfactory or needs improvement as a final score in any single competency results in a clinical course grade of unsatisfactory; this is a failure of the course. The terms Satisfactory and Unsatisfactory will be used in evaluating the final grade or clinical course performance.

Needs Improvement (NI): Safe; accurate each time; skillful in parts of behavior; focuses more on the skill and self rather than the patient; inefficient, uncoordinated, anxious, worried, flustered at times; expends excess energy within a delayed time period, frequent verbal and occasional physical directive cues in addition to supportive cues; faculty feedback required in several areas of clinical written work.

Unsatisfactory (U): Failure to achieve the course competency, safe but needs faculty reminders constantly, not always accurate, unskilled, inefficient, considerable expenditure of excess energy, anxious, disruptive or omitting behaviors, focus on skills and/or self, continuous verbal and frequent physical cues, unsafe, performs at risk to patient/clients/others, unable to function, incomplete, erroneous, faulty, illegible clinical written work, no feedback sought from faculty or response to feedback not evident in submitted written work. If the student does not self-rate a competency the competency is graded "U." A "U" in a competency must be addressed in writing by the student in the Evaluation of Clinical Performance tool. The student response must include how the competency has been or will be met at a satisfactory level. If the student does not address the "U," the faculty member (s) will continue to rate the competency unsatisfactory.

Week 1 (1h)- During week 1, the Meditech, FSBS and IV pump sessions were all considered clinical hours. You came prepared to each of them and demonstrated competency accordingly. For this reason, you have earned an S for this competency. NS

Week 3 – 1a , b, c, e– You did a nice job caring for your patient with exacerbation of asthma and COPD. You did a nice job discussing on clinical your patient’s disease process and what nursing was doing to help the patient. You were able to discuss symptoms we were monitoring and managing in your patient as well as pertinent labs for your patient diagnosis. You also set a goal for your patient and were able to discuss your patient’s work towards meeting that goal. KA

Week 3 – 1d – You did a nice job reviewing all your medications before you administered them to the patient. You sometimes did not focus on all the pertinent side effects when going through initial review with me. You were able to discuss the reason why the patient was taking the medication as well as what we were monitoring the patient for. You were not clearly able to identify on day one all information that was needed to determine if the medication should be administered (i.e. blood pressure, pulse), however on day 2 you were easily able to identify all information with any prompting. Wonderful job! KA

Week 4 1(a-h) – You were able to discuss your patient’s alterations this week related to COPD and GI bleed. You identified numerous signs and symptoms related to each disease process and discussed the pathophysiology involved. You correlated her medications to her current disease process and discussed nursing implications for each. You review the diagnostic testing performed and correlated her continuously low hgb levels to the prescribed treatment of blood transfusions. You also discussed the findings of the EGD related to esophagitis and hiatal hernia. Good job discussing your patient and beginning to put the pieces together to enhance your clinical judgment. NS

Week 5 (1h)- Stevi, please keep in mind that Infection Control, Digestive Health, and the Erie County Senior Center, while not your typical inpatient clinical, are still clinical experiences. In the future, be sure to review each competency and evaluate as appropriate. For example, competency 1h asks you to evaluate whether or not you demonstrated evidence in being prepared for clinical. Did you prepare for the IC experience by reviewing the isolation precaution quick reference guide and bring your clinical paperwork that was mentioned in the syllabus? If yes, the evaluation could have been an S. If not, it would have been an NI or U. DW

Week 6 1(a-h) – As team leader, you analyzed the four assigned patient’s disease processes and pathophysiology involved to appropriately prioritize your day and the care required. You discussed the assessment findings with your peers to correlate their signs and symptoms identified related to a TIA, mediastinal mass, gastroparesis, and cellulitis. You reviewed diagnostic tests performed on each patient and discussed the findings. You reviewed the medications prescribed with each student, including the implications, side effects, and nursing assessments that needed to be performed in order to safely administer the medications. Overall you gained experience in developing an understanding of numerous disease processes related to your team leading experience. NS

Week 7: (1 c, d, e)- This week you did a great job discussing your patient’s pathophysiology of their illness as well as had a great discussion of their medications and why they were relevant to their care. RH.

Week 11 – 1a, b, c, e– You did a nice job discussing on clinical your patient’s disease process related to an acute exacerbation of her COPD and what nursing was doing to help the patient. You were able to discuss symptoms we were monitoring and managing in your patient as well as pertinent labs for your patient diagnosis. You were able to discuss the different patients on your team and prioritize the patients according to their diagnosis and assessment. You utilized your knowledge and change in patient status to reprioritize the patients as the day went on. KA

Week 11 – 1d – You did a nice job reviewing all your medications before you administered them to the patient. You were able to discuss the reason why the patient was taking the medication as well as what we were monitoring the patient for. You also were able to discuss what information was needed to determine if the medication should be administered (i.e. blood pressure, pulse). You were able to discuss the medications of all the patients on your team and was able to work with your team member to determine appropriateness of medication administration. KA

Rehab Clinical Objective 1 B-E-This week you were able to identify symptoms, medical treatments, pharmacotherapy, and diagnostic tests that were a part of the patient’s stay on the Rehab unit. You did a great job in correlating all of these with the patient’s diagnosis. Great job! MD

Week 5 (2f)- Again, please be sure to review all competencies each week to reflect on whether or not you completed it during the experience. Typically, students are required to look at patient documentation and determine if the nurses are documenting the correct isolation precautions. If you did this, you could have evaluated yourself as S for 2f. DW

Week 6 2(e) – As team leader, you were asked questions related to priority assessment needs for each patient you were assigned to oversee. You did a good job of identifying the focused assessments to be performed for each. For the patient with a TIA, you discussed the importance of monitoring neurological status to identify potential changes. For the patient with the mediastinal mass, you discussed the importance of closely monitoring the chest tubes and respiratory status. For the patient s/p surgery for cellulitis, you discussed the importance of monitoring the wound vac and dressing site while also assessing for complications of circulation. For the patient with gastroparesis, you discussed monitoring blood sugar levels, pain, and nutritional status. NS

Week 7: (2 a-f)- This week you did a good job of performing your head to toe when time was available to you due to the therapy scheduling. You worked around therapy schedules to get your head to toe as well as your reassessment done. You also were able to document and find other assessment pieces in the electronic health record. RH

Week 11 – 2a, d – You did a nice job thoroughly assessing your patient and notifying your nurse of any pertinent information. You were also able to work with your team to keep up on the assessment changes occurring with all patients on the team. KA

Week 11 – 2f – You utilized the EMR to research your patient and determine what care needed to be provided to your patient throughout the day. You also used the EMR to research all the patients on your team and to check your classmates charting for accuracy. KA

Week 4 3(b,c,d,e) – You did well this week performing new skills and prioritizing your time appropriately. You gained experience with preparing intravenous infusions using aseptic technique. You also safely performed a saline flush, identifying infiltration of an IV site, and demonstrated competence in D/Cing the IV while promoting

safety. You prioritized your assessments well and communicated your findings with the assigned RN for follow up. You recognized the need for assistance during your time caring for the patient and used good communication to relay your findings. NS

Week 6 3(c,d) – Nice job using clinical judgment in discussing your priorities for the day as team leader. You were asked questions related to the top priority patient and how you would manage your day. You appropriately identified the patient with a mediastinal mass with two chest tubes placed for drainage as your top priority patient to assess first. You identified the importance of monitoring the chest tubes closely due to the leak in chest tube number two and his respiratory status. You then prioritized the patient admitted with cellulitis and necrotizing fasciitis that underwent surgery the day before. You noted her altered mental status and safety risks associated with the wound vac being in place. You then focused your care on the patient admitted with a TIA with a cervical halo device in place, noting the importance of assessing for neurological changes and risk for injury. Lastly, you prioritized the patient admitted with abdominal pain diagnosed with gastroparesis with stable vital signs. You did well to discuss your prioritization through out the day when caring for multiple patients. NS

Week 7: (3 c, d, e) This week you demonstrated good organization and time management when it was time for medication administration. This was difficult due to the varying therapy schedules we had to work around. You did a good job looking up your medications, administering medications, completing your head to toe, and charting your findings while also participating in therapy with your patient throughout both days. You were not afraid to ask for assistance when needed. You were able to recognize your patient's blood pressure was very elevated and rechecked the blood pressure with a manual cuff and administered his daily antihypertensive medications. You then went in and rechecked his blood pressure about 45 minutes later to ensure his blood pressure was returning to normal, great job. RH

Week 11 – 3b – You did a great job developing a rapport with your patient and her family. Your patient expressed extreme happiness with the care you provided her. You went above and beyond to make her feel welcome and at home while in the hospital and supported her with the necessary information upon her discharge. KA

Week 3 – 3r – You did a nice job monitoring your patient's IV site this week and documenting your assessment in the EMR. KA

Week 4 3(k-s) – You did well this week with medication administration. You discussed the 6 rights, practice the 3 safety checks, performed accurate dosage calculation, and safely administered medications to your patient using the BMV scanner. You gained experience with administering PRN medications, ensuring the appropriate time frame and discussing nursing implications for the PRN anti-anxiety medication. You adequately prepared intravenous tubing for a intermittent anti-viral medications and programmed the pump accurately. You also gained experience with changing infusion bags utilizing pre-existing tubing using aseptic technique. While performing a saline flush to confirm patency, you noticed a non-functioning, infiltrated IV site and showed competence in removing the IV safely and documenting your care accurately. Great job! NS

Week 6 3(k-s) – As team leader you assisted your peers with medication administration, ensuring safety measures were in place, and discussing important considerations for each medication. You assisted with numerous PO medications, subQ injection, preparing IV fluids, flushing IV sites to confirm patency, and programming the IV pump accurately. You discussed appropriate dosage calculations, identified the six patient rights, and performed the three safety checks. NS

Week 7: (3 k, l, m)- You were well prepared for medication administration this week and you performed all checks well! You used the EMAR to look up medications that were due then used skyscape to further investigate each medication. You answered all my questions well and your medication pass went smoothly! You had so many medications and you did great going through them with me. RH

The title of the article should not be in italics and should be all lower case except for the first word and words following a colon – Improving the patient experience and decreasing patient anxiety with nursing bedside report. The journal itself should be capitalized and typed in italics – *Clinical Nurse Specialist*, 33(2), 82-89, followed by the hyperlink or DOI. The in-text citation should include the “&” symbol between the two authors last names. Be sure to use the feedback provided to improve on the APA formatting. All criteria were met for a satisfactory evaluation. NS

Week 5 (4e)- According to the CDG Grading Rubric, you have earned an S for your participation in the Infection Control discussion this week. Your discussion was thoughtful and supported by evidence. The CDC is an excellent resource on this topic; it is both valid and reliable. I have one suggestion for future improvement with APA formatting. When you use a direct quote, the citation should include the author(s) last name, the year of publication and the page or paragraph number. This would be an example of an APA formatted citation- (Centers for Disease Control and Prevention, 2023, para 2). Keep up the good work! DW

Week 6 4(e) – Nice job with your team leader CDG this week. You discussed your day well, including issues that arose and how you handled the situation. You described your thought process well and answered all question prompts with good detail. A reputable resource was utilized to support the discussion with accurate APA formatting. Unfortunately, this competency was changed to “U” due to lacking a response post to a peer this week. The team leading experience does require a response post to a peer that includes and in-text citation and a reference. I was unable to locate a response post this week. Example: Education related to orthostatic hypotension (changing positions slowly by sitting at the side of the bed or chair for a few minutes before moving to another position, utilizing the walker when ambulating) was provided to my patient through discussion and demonstration. This was necessary to maintain patient safety as he/she was experiencing a drop-in blood pressure and dizziness when getting out of bed. A patient education sheet was printed from Lexicomp and given to the patient. The teach back method was used to validate learning.

Comments:

Week 3- 5a and b. I educated verbally to my patient on the importance of coughing and deep breathing because of not ambulating as much while in the hospital and to help with her COPD exacerbation. This was necessary to promote better airway clearing and to decrease the risk of atelectasis. I used Skyscape to educate myself on this so that I could verbally explain and show the patient. I then had her perform this activity in front of me. Great job! You might want to consider using Lexicomp in the future for this information because a patient handout on this content your patient could take home may have been useful to her. KA

Week 4- 5a and b. A teaching need of my patient was the importance of being mobile while in the hospital. Even though she was weak, she did not want to use anything besides the bedpan which was not helping her maintain her strength. I did not print out anything regarding this information, but I did make sure to educate her verbally when I was in the room and also made sure that the others taking care of her did this as well. Good! This is an important teaching need that requires continuous reminding and motivation. Although she was experiencing a lot medically, her condition will only continue to decline if she does not move and get out of bed periodically. Communication among team members to reinforce the education is essential. Good thoughts. NS

A teaching need for the patient that we took care of with gastroparesis this week was that it is very important to drink plenty of fluids to try to keep things moving and prevent dehydration. The patient had not had a bowel movement in almost a week, so she was suffering from abdominal pain. She was not given a handout, but many healthcare workers were educating her on the importance of this. NS

Week 7 5a and b. A teaching need for my patient this week was how to do exercises on his own to recover from his stroke. To provide proper education for these exercises, the occupational therapist demonstrated them and then had him teach them back to her, along with giving him a printed-out packet of directions on how to do them on his own. Did you reinforce this education with him? This competency is about what you educate the patient on, so be sure you are explaining how you are educating the patient. RH

Week 10 5a. A teaching need for my patient on 4 north this week was diabetes management. He was noncompliant with his meds at home and became hyperglycemic which was one of the reasons why he was admitted to the hospital. His nurse and I and many other healthcare workers did our best to educate on the importance of correctly

managing his diabetes both at home and in the hospital. Because so many of were educating him, I did not give him a handout, but that is something that I would do in the future. **NS**

Week 11 5a and b. My patient got discharged at the end of our clinical day, so her teaching need was education on her new medication to take at home. The resource that we used for this was the discharge packet that each patient receives when they are let out of the hospital. She was put on 13 new medications while in the hospital and was to continue them when she went home, so her nurse and I sat down and went over them with her, her daughter, and her husband and answered any questions that they had about each one. **Nice job! KA**

Week 12 5a and b. A common teaching need of my patient was that when you go to stand up you should place your hands on the bed, chair, or whatever you are sitting on to get up, not your walker or whatever is in front of you. She had a tendency to grab her walker when she went to stand up instead of her bed or wheelchair, which is a huge fall risk because the walker could move, causing her to fall. Both her physical therapist and I repeatedly educated her on this multiple times, and her physical therapist made sure to teach her the proper body mechanics to do this with as well. Her physical therapist was a very good resource to get her back to her baseline activity before she could go home. **Great education! Where else could you have obtained the information? MD**

Because of this, she does not receive checkups to help maintain her COPD and other health problems. She also does not receive proper education and exercises related to her disease. If she had a PCP she would most likely have to make less trips to the hospital and would have someone checking up on her health regularly. **Great information to identify. This does affect how she manages her overall health. While she is in the hospital this is the perfect time to address this topic and help her identify possible PCPs she can utilize. KA**

Week 3 – 6a – You satisfactorily completed your care map on your patient this week. Please see comments on the rubric at the end of the tool for details. KA

Week 4- 6b. I think that education is a SDOH that my patient lacked while she was in the hospital. Her and her family seemed to never really know what was going on, which caused them a lot of anxiety. They received verbal education from many different people in the hospital, but another form of education is probably needed to lower the stress of her and her family. **The education portion of SDOH focuses on the patient's level of education received which in turn can impact her understanding of the instructions being provided. Those with lower levels of education will require a more simplistic form of education to promote positive outcomes. As nurses, if we identify a patient that may be at risk, its important that we tailor our education to a level that is best understood. We can also provide resources to help understand the education provided. NS**

Week 5- 6b. I think that education is an appropriate SDOH for this clinical. I don't think that many people realize the true importance of hand hygiene and the appropriate precautions to prevent the spread of infection while in the hospital. I think that if more people took this process seriously the spread of infections would decrease. I think that it is a good thing for all people to get checked off on hand hygiene while employed in the hospital setting. **Stevi, while I agree with your statement, I am not sure that you fully grasp the concept of SDOH. In terms of education as a SDOH, someone that does not speak English or an adult that does not have at least a high school diploma**

may have issues with health literacy and the lack of education could negatively impact their health. Healthcare professionals typically have at least an associate degree in college or higher, so its not necessarily a literacy issue when someone doesn't perform hand hygiene appropriately. Please take a little time to review the CMS- Social Determinants of Health document that is located in the Clinical Resources on Edvance360 to ensure you better understand this concept for future clinical weeks and tools. I am always available if you have additional questions. DW

Week 7 6b. My patients SDOH for this week is that he has left sided weakness and has stairs in his house. He had a hard time getting up the stairs in PT and has more stairs in his house. This is a huge safety risk, so I hope that when he gets home he figures out a way to have all of his resources downstairs to ensure safety. Did he have any family members or friends who were assisting the stairs to be more accessible to him? What resources could we provide him with to allow him to have an easier transition to home? RH

Week 9 6b. A SDOH for the older adults at the senior center is transportation. Many of them rode the bus to get to and from the ECSC. This could be a problem for them to get to their doctors' appointments or getting to a pharmacy to pick up their medications, which then creates an even bigger problem for their overall health which is scary. DW

Week 10 6b. An SDOH for a patient I saw in digestive health is lack of education, because for his EGD he was supposed to be on a low fiber diet for at least a week before his procedure. During his procedure it took the doctor a longer time because he had not followed the correct diet. This is concerning for other things in his lifestyle such as his medications and can be a huge safety risk. NS

Week 11 6b. Lack of transportation is the SDOH that I think my patient would have a chance of struggling with because neither her or her husband or supposed to be driving. She is on PRN oxygen so that is a huge safety risk and they both use walkers. Her daughter lives with her but is not always available. This worries me because she does have a history of COPD and gets SOB easily, so doctors' appointments are very important for her to attend. Great thoughts and a concern that can be addressed to help your patient better manage her chronic health conditions. KA

Week 12 6b. My patient this week was brought to the hospital because she was found passed out in the middle of a store. This is a huge concern and would address the SDOH of transportation and because we now know that she is at such a high risk for syncope, she should no longer be driving, which is a concern to me for when she gets out of the hospital and how she is going to get to her follow-up appointments, food, and any other necessities. Great SDOH! MD

As health care workers we will experience situations with patient's that can negatively impact your own mental health. Always be sure to address this and don't allow patients to continue that type of behavior. Again, I am sorry that you had to experience this during your clinical rotation. NS

Week 10 7b. An area for improvement for this week is when I am giving insulin, I need to make sure to hold the needle against the skin for at least 5 seconds after injecting. After our discussion and gaining more experience with insulin administration, I am sure you will improve upon this with your next opportunity.
