Homework Assignment Questions and Answers

Please read the chapter and answer the following questions:

1. **Malpractice and negligence are examples of what kind of law?**

Malpractice and negligence are examples of unintentional torts, falling under the tort law.

2. **What charges may be brought against a nurse for confining a client against his or her wishes (outside of an emergency situation)?**

The nurse may be charged with false imprisonment for confining a client against his/her wishes.

3. **Which ethical theory espouses that what is right and good is what is best for the individual making the decision? Which quality and safety in nursing education competency may be, at least in part, consistent with ethical egoism?**

Ethical egoism espouses that what is right and good is what is best for the individual making the decision. Providing patient-centered care as a healthcare professional has similar elements of ethical egoism because it promotes listening and respecting the patient's values, preferences, and needs.

4. **Name the three major elements of informed consent.**

The three major elements of informed consent are knowledge, competency, and free will.

Knowledge relates to the patient's information regarding their decision, competency relates to the individual's cognition not being impaired or interference with decision-making, and free will relates to if the individual has given consent voluntarily without pressure or coercion.
