Week 4 (1a-e)- Great job with your CDG this week! Nice job discussing your client's mental health history and providing resources related to their diagnosis! I changed 1f to "NA" since you did not provide the activity this week.SA

Week 5- 1a- You did a great job identifying and discussing various risk factors often associated with substance abuse and some of the family dynamics often prevalent when substance abuse is present. 1b- You also discussed some of the characteristics that are often present in those with substance abuse issues. 1d- Nice work discussing the need for mental health programs and strategies to help those in recovery. Week 6 1(c) – Nice work discussing potential barriers to culturally and spiritually competent care at the Erie County Detox Center. You identified the lack of religious services available at the detox center as a potential barrier to continued recovery beyond the detoxification process. You were able to identify the importance of religion to some clients and incorporating religious services could provide hope and positive behaviors. Spirituality can play a very important role in recovery and would be great for the detox center to incorporate. I wonder if they provide access to the Bible or other religious documents for the clients while they are there. Good thoughts! NS

Week 6 1(d) – Good discussion provided related to assisting clients in regaining independence at the Detox center. You were able to identify the importance of therapies provided at the center aimed at identifying positive coping mechanisms to improve their quality of life. You also focused on the importance of maintaining structure that can be beneficial in achieving self-care with daily hygiene and nutrition. Allowing clients the ability to check in and out of the detox center also provides a sense of independence in their recovery. As you identified, sometimes the clients overall physical health during detoxification can impact their ability to perform self-care such as hygiene. It's great to hear that the nurses are active in helping clients achieve this level of care. Well done! NS

Week 7- 1a- You did a nice job describing the environment during your time at Hospice. As you discussed, it is typically calm and peaceful inside the hospice unit, and the nurse and staff there do a very good job at maintaining it. You also discussed that the nurses there have several roles they must play at once. From taking care of the patient's needs to pain control to providing support to many family members, and sometimes all at once. Nice work! BS
