If there is a discrepancy in the performance code evaluation between the student and the faculty member, a note is written in the comment section by the faculty member with the rationale for the evaluation. All competencies must be rated a “S, NI, U, or NA”. If the student does not self-rate, then it is an automatic “U”. A student who submits the clinical evaluation tool late will be rated as “U” in the appropriate competency(s) for that clinical week. Whenever a student receives a “U” in a competency, it must be addressed with a comment as to why it is no longer a “U” the following week. If the student does not state why the “U” is corrected, it will be another “U” until the student addresses it. All clinical competencies are critical to meeting the objectives of the course. **An unsatisfactory or needs improvement as a final evaluation in any single competency results in a clinical course grade of unsatisfactory; this is a failure of the course. Patterns of performance over the course of the semester will be utilized to determine the final competency evaluations. The terms Satisfactory and Unsatisfactory will be used in evaluating the final grade or clinical course performance.**

### UNSATISFACTORY CLINICAL PERFORMANCE

**Needs Improvement (NI):** Safe, accurate each time, skillful in parts of behavior, focuses more on the skill and self rather than the patient, inefficient, uncoordinated, anxious, worried, and flustered at times, expends excess energy within a delayed time period, frequent verbal and occasional physical directive cues in addition to supportive cues, faculty feedback required in several areas of clinical written work.

**Unsatisfactory (U):** Failure to achieve the course competency, safe but needs faculty reminders constantly, not always accurate, unskilled, inefficient, considerable expenditure of excess energy, anxious, disruptive or omitting behaviors, focus on skills and/or self, continuous verbal and frequent physical cues, unsafe, performs at risk to patient/clients/others, unable to function, incomplete, erroneous, faulty, illegible clinical written work, no feedback sought from faculty or response to feedback not evident in submitted written work. If the student does not self-rate a competency the competency is graded "U." A "U" in a competency must be addressed in writing by the student in the Evaluation of Clinical Performance tool. The student response must include how the competency has been or will be met at a satisfactory level. If the student does not address the "U", the faculty member (s) will continue to rate the competency unsatisfactory.

- A. My area of strength was my ability to talk to my patient. He was very confused and unaware of certain things going on, and I was able to explain my procedure to him in a way he was able to comprehend, and work with me during the assessment and vitals. I explained everything before doing it, and confirmed with him that he was okay with what we had to do. **Great job communicating with your assigned patient this week. It is difficult to communicate with a confused individual, just remember to keep things simple and repeat if necessary. FB**
- B. An area of improvement for me is getting a handoff report. I tried my best to keep up, but I was trying to write faster than I actually can and kept writing info in the wrong boxes for myself. I will work on fixing this by being better prepared. My first day was a surreal moment that I was really excited about, but my excitement took away from my focus. I can also look ahead at my handoff sheet to see where I will be putting specific information instead of winging it like I did. With better organization and being mentally prepared I can begin to improve. **Try to familiarize yourself with the report sheet and don't be afraid to ask questions or for the nurse to repeat. This will get better over time with experience. FB**

**Comments:**

**Week 7- All competencies for objective 8 are unsatisfactory because you did not address any of them. Alejandro, some advice for you is to be early to clinical, have all of your paperwork, and necessary equipment ready to go ahead of time. You need to have better organization skills. Do not wait until the last minute to complete all requirements. These qualities will carry over into the care of patients. You will need to be thorough, read threw orders, carry out those orders correctly, on time, and efficiently. As the nurse it will be your responsibility to care for patients ensuring positive outcomes. FB**

**Week 8(8a-i): Alejandro, you did not self-rate yourself for these competencies in week 7 and you did not address them for week 8, therefore you receive a "U". I can't wait until I see myself improve and become the best I can be. **I appreciate your honesty and insight in recognizing the importance of preparation. It's clear you're taking accountability and already developing an excellent plan to improve your organization. Learning from experiences like this will help you grow in professionalism—your motivation to do better shows strong self-awareness and commitment to becoming the best nurse you can be. BL**

I have received all U's because I completely missed the entire section and failed to fill anything out. I need to double-check my work to make sure I am doing everything and not missing parts of the assignment. I will be changing these to S because I am addressing my mistakes and know I can continue to improve. I will have to give myself a U in exhibiting professional behavior in the clinical setting because I forgot my stethoscope. I tried to prepare differently to improve my ability to be better prepared, but didn't check all the boxes and made a big mistake. I will fix this by having a list of materials I need and double-checking that I am prepared for clinical. **Thank you. BL**

You arrived to clinical unprepared, having forgotten your stethoscope, and needed to borrow one in order to safely assess and care for your patient. You handled both of these situations very calmly. You noticed there was a change in your patients, and you sought out appropriate help right away. You also did a nice job remaining present to assist the nurses and take advantage of the learning opportunity.** BL
- B. My area for improvement this week would be looking up my patients' lab work and other tests. I didn't know enough about their levels and didn't have enough written down. I need to be able to draw more connections between their condition and my assessments with those results and medical conditions. I can improve on this by spending some more time in my patient's chart to write down abnormal results. I can also look up symptoms of their conditions to compare with their actual signs and symptoms. **This is an excellent area for continued growth. It's important to develop a strong understanding of each patient's laboratory results and diagnostic tests in addition to your own assessment findings. Together, these elements create a complete clinical picture and guide the selection of appropriate nursing interventions and the overall plan of care. Another area for improvement is overall organization in completing clinical assignments accurately and on time outside of the hospital environment. There has been some evidence of disorganization. Professionalism in nursing extends beyond patient care—it also includes responsibility, time management, and accountability in all aspects of your work. Strengthening these skills will support your growth as a competent and dependable nurse. With that being said, due to a pattern of behaviors, you will be required to write a scholarly paper on the topic of "Professionalism." Please refer to my email for further details on the requirements. This will be due on Saturday, November 8, 2025 at 2200 in your personal dropbox.** BL

**Week 11-8(f)** This competency has been rated as needs improvement for this week in the area of professional behavior. Unfortunately, you did not complete your CDG questions for Week 11. - A. My area of strength this week was being able to administer my patient's medication successfully. I gave three of them per oral, and one intramuscular injection. I was nervous about moving too much with the IM injection, but the patient said it was great and gave me an "A plus." Alejandro, you did an excellent job with your first medication pass! You demonstrated both skill and confidence. BL**
- B. My area for improvement would be encouraging my patient to be more active with his care and therapy. He refused baths from me both days, and I observed him declining occupational therapy. Looking back, I feel like I should have educated him more on how a daily bath and just getting washed up a little bit can make a big difference. On top of that, I wanted him to do therapy because he sat in bed without wanting to participate, and didn't want a sore to manifest from his decline of ADLs. You did a great job reflecting on your experience with this patient. As an RN, motivating patients and helping them understand why certain activities, like bathing or participating in therapy, is so important. Even small conversations can help them feel more in control and more willing to try. Keep practicing those communication skills and don't be afraid to gently encourage patients or explain things in a way that connects to what matters to them. Great job! BL**

**Week 13-8(a,b,i) Nice job reflecting on your medication administration experience in your CDG. I appreciate your openness in discussing your expectations, concerns, and the challenges you faced. 8(c, f) This week, you demonstrated growth in completing assignments, following instructions, and meeting established deadlines. These skills are essential not only for success as a student, but also for fulfilling the responsibilities of a Registered Nurse (RN). RNs must consistently follow policies and procedures, manage multiple priorities, and ensure that all tasks are completed accurately and on time to support patient safety and quality care. While there is still room for improvement, you have shown both the ability and dedication to continue making progress. Continue to work on organizational strategies such as using planners, checklists, or time-management tools. Building strong organizational habits now will support your future role as an RN. BL**
