Week 5 (Meditech/BMV):

Week 6 (Wound Care): You were satisfactory with placement of sterile gloves during lab this week! Although you performed very well with many aspects of the wet to dry sterile dressing change, you ultimately were unsatisfactory with this skill due to the following: you did not properly identify your “patient” by asking for their name and date of birth; you didn’t fully assess the dressing and wound for drainage; when cleansing the wound you “poured” saline on a 4X4 and quickly ran that over the wound; the 4X4 you utilized for cleansing the wound was contaminated as it was bunched up in your gloved hand (the areas of gauze touching the wound cannot be touched); you stated that you “would do a wound culture before cleaning the wound”; you did not dry or attempt to dry the wound prior to placing the packing or dressing; you contaminated your sterile glove with the cotton-tipped applicator package (and didn’t recognize this as a breach of sterility). For future success I suggest practicing this skills several times, and organizing the supplies prior to beginning the procedure. You did complete wound

documentation in Meditech Expanse, with assistance of faculty. Please remember that this was your first skills lab and actual Meditech documentation. You will get a lot more practice in the lab with skills and documentation, and will become more comfortable! AR

10/22/19: Wound Care remediation. You were satisfactory with the Wet to Dry Sterile Dressing change during remediation! Great job! You performed each step accurately and thoroughly, while maintaining sterility of the supplies. In the future be careful to only touch the edges of the 4X4's when drying and covering the wound, rather than touching the center portion that will be in contact with the wound. Keep up the great work!!

Week 9 (NG Insertion/Care): Kim, your satisfactorily performed NG insertion, irrigation, and removal skills, nice job. Although you were unsure of yourself at times, you performed all steps without prompting. Confidence in performing skills will increase with continued practice. You did a nice job explaining the procedure to the patient. Nice work! CP

Week 10 (Foley Insertion/Care): Kim, you were satisfactory in completing Foley Catheter insertion and removal. Remember to watch your sterile field at all times and do not cross over your sterile field. Also, remember to remove any jewelry which may prevent the ability to maintain sterility throughout the procedure. CP
