All CRST Home Solutions service providers are expected to follow the dress guidelines outlined in this manual. In this document you will find CRST Home Solutions' standard dress guidelines, as well as specific guidelines by client. If you perform jobs for a client who outlines specific dress guidelines, you are expected to comply with those client-specific guidelines.

This purpose of this document is to help our service providers:

- Present a professional appearance to customers, clients, and the public
- Promote a positive working environment by limiting distractions caused by inappropriate or unprofessional dress
- Ensure safety while working



CRST Home Solutions' Standard Service Provider Dress Guidelines

All CRST Home Solutions service providers are expected to follow the dress guidelines outlined below *IF* no client-specific guidelines apply.

Professional appearance, style, and hygiene

Keep hair neat, clean, and conservatively styled; keep facial hair trimmed and neat in appearance

HATS:

Hats with CRST Home Solutions logo, your own business name, or no logo are permitted

SHIRTS:

Clean, appropriately sized collared shirt with CRST Home Solutions logo, your own business name, or no logo

PANTS:

Clean and appropriately sized khakis, work pants, or dark jeans with no holes/designs

SHOES:

Closed toe work shoes or boots appropriate for job site
Use shoe covers while inside customer's home

COLD WEATHER:

Servicers may wear clean long-sleeved shirts with no tears under their collared shirts

Servicers may wear clean jackets, parkas, or winter coats with CRST logo, your own business name, or no logo



To order CRST Home Solutions Polo shirts, use the “Order Shirts” feature in DOLI.

Ordering CRST Home Solutions Polo Shirts via DOLI

CRST Home Solutions logo shirts range from \$22.50 to \$47.00 per shirt, depending on the size ordered. We recommend that servicers who work on jobs CRST Home Solutions jobs should have at least one; servicers who frequently work jobs CRST Home Solutions jobs should have multiple shirts.

1. Log in to DOLI with your administrative username and password.
2. Click the **ORDER SHIRTS** button on the main navigation panel of the DOLI homepage.
3. Compile and submit your order.



Note: Shirt prices displayed in DOLI include shipping.

PROHIBITED ITEMS

The following items are unprofessional and may pose safety hazards. These items are not allowed at any time by any client on any job.

- “Hoodie” sweatshirts
- T-shirts
- Shorts
- Torn clothing
- Baggy or low-rise pants
- No visible pierced body jewelry (including tongue, nose, and eyebrow), excessively pierced ear jewelry, or jewelry that presents a safety hazard
- Tattoos that may be considered offensive (violent or sexually explicit images, profanity) must be covered
