- When treating a client select interventions that maintain client safety while posing the least amount of restriction to client (Holman et al., 2019)
- Select interventions that are the least invasive such as bladder training before more invasive interventions (Holman et al., 2019)
- Use the nursing process of assess, diagnose, plan, implement, evaluate when treating clients (Holman et al., 2019)

- Referral to occupational and physical therapy for home safety assessment (Holman et al., 2019)

- Only healthcare team members directly responsible for the client's care are authorized to access client information (Holman et al., 2019)

- Include significant objective information about the client's health problems (Holman et al., 2019)
- Include no gossip or opinion (Holman et al., 2019)
- Relay recent changes in medications, treatments, procedures, and the discharge plan (Holman et al., 2019)

Topic: Information Technology: Using Correct Documentation

- Subjective data are listed as direct quotes from the client's statement and supported by objective data (Holman et al., 2019)
- Objective data should include what the nurse sees, hears, feels, and smells without the use of inappropriate statements (Holman et al., 2019)
- All information collected is confidential and promotes client safety (Holman et al., 2019)

- Identify environmental health risks and advocate for the improvement of environmental quality (Holman et al., 2019)
- Implement risk communication (Holman et al., 2019)
- Testing for lead-based paint in housing (Holman et al., 2019)

Topic: Safe Medication Administration and Error Reduction: Identifying Electronic Databases for Research

- Know the medication and side effects prior to administering medication (Holman et al., 2019)
- Ensure the right client, right medication, right route, right time, and right dose prior to administration (Holman et al., 2019)
- Check that no interactions or contraindications prior to administration (Holman et al., 2019)

Topic: Safe Medication Administration and Error Reduction: Transcribing a Telephone Medication Prescription

- Ensure that the prescription is complete and correct by reading the prescription to the provider (Holman et al., 2019)
- Enter the prescription in the medical record (Holman et al., 2019)
- The prescription includes the client's name, name of medication, dosage, time to give, frequency, and route (Holman et al., 2019)

Subcategory: Emergency Response Plan

Topic: Emergency Preparedness: Disaster Preparedness

- Disaster agencies include FEMA, CDC, U.S. Department of Homeland Security, American Red Cross, OEM, and the public health systems (Holman et al., 2019)

- Stress counseling and PTSD assessment are vital components after a disaster (Holman et al., 2019)
- Define the role of the nurses in first, second, or third-level triage (Holman et al., 2019)

- Alignment of the body keeps the center of gravity, reducing potential strain on the muscles (Holman et al., 2019)
- Always use mechanical lifts whenever possible to lift and transfer clients to prevent injury (Holman et al., 2019)
- Spread the feet for a broad base and bend the hips and knees when lifting (Holman et al., 2019)

Topic: Nursing Care and Discharge Teaching: Teaching About Newborn Safety

- The newborn must not be submerged in water until the umbilical cord has fallen off and the circumcision has healed (Holman et al., 2019)
- Set the water heater to 120.2F or less to prevent burns (Holman et al., 2019)
- Place newborns on the back when napping to prevent SIDS (Holman et al., 2019)

Topic: Safe Medication Administration and Error Reduction: Priority Action Following a Medication Error

- Notify the provider of a medication error and assess the client for adverse effects (Holman et al., 2019)
- Submit an incident report within twenty-four hours of the incident and do not include it in the medical record (Holman et al., 2019)
- An incident report must include the client's identification, time, place, account of events, and signature (Holman et al., 2019)

Subcategory: Standard Precautions/Transmission-Based Precautions/Surgical Asepsis

Topic: Infection Control: Identifying Need for Sterile Gloves

- Standard precautions include hand hygiene with alcohol-based sanitizer after contact with a client and ensuring hands are not visibly soiled (Holman et al., 2019)
- If care involves splashing or spraying, the nurse must don a mask, eye protection, and face shield (Holman et al., 2019)
- Measles, varicella, and tuberculosis require airborne precautions and a private room (Holman et al., 2019)

Topic: Professional Responsibilities: Recognizing Reportable Communicable Diseases

- A client diagnosed with a communicable disease is required to report to local and state health departments (Holman et al., 2019)

- Mandated reporting allows healthcare professionals to determine adequate medical treatment for the disease is available (Holman et al., 2019)
- A foodborne communicable disease reported by healthcare professionals is hepatitis A (Holman et al., 2019)

Main Category #3: Health Promotion and Maintenance

Subcategory: Ante/Intra/Postpartum and Newborn Care

Topic: Prenatal Care

- Prenatal visits are scheduled for weeks 16 through 28, every two weeks from 29 to 36 weeks, and weekly from 36 weeks until birth (Holman et al., 2019).
- The estimated date of birth is calculated based on the first day of the last period; subtract three months and add seven days (Holman et al., 2019).
- Fetal assessments are done during prenatal visits to fetal development and assess potential complications with the birth, such as hypertension, gestational diabetes, or hyperemesis (Holman et al., 2019).

Subcategory: Developmental Stages and Transitions

Topic: Health Promotion of Toddlers: Assessing Developmental Milestones

- By the age of two, the toddler's language expands to fifty and up to three hundred words (Holman et al., 2019)
- Toddler at eighteen months runs clumsily and often falls (Holman et al., 2019)
- The toddler can build a tower of two blocks at fifteen months (Holman et al., 2019)

Subcategory: Health Promotion/Disease Prevention

Topic: Gastrointestinal Therapeutic Procedures: Evaluating Teaching About Bariatric Surgery

- Laparoscopic sleeve gastrectomy reduces stomach capacity, and the client must adhere to strict weight loss protocols and lifestyle modifications (Holman et al., 2019)
- Overeating causes the surgery to fail because the weight will regain through stretching of the stomach (Holman et al., 2019)
- In the first six weeks after surgery, the client must only eat liquid and pureed foods and not exceed one cup (Holman et al., 2019)

Topic: Infections of the Renal and Urinary Systems: Planning Care for a Female Client Who has Recurrent Urinary Tract Infections

- The female sex has a higher prevalence of UTIs because of the short urethra for women (Holman et

al., 2019)

- Instruct the client to drink three liters of fluids a day to prevent UTIs (Holman et al., 2019)
- Instruct the client to urinate every three to four hours to avoid holding in urine and filling the bladder (Holman et al., 2019)

Topic: Health Promotion of Infants: Finding to Repot

- Infants' anterior and posterior fontanelles by the age of twelve to eighteen months are both closed (Holman et al., 2019)
- Infants at five months old develop enough to roll from the front to the back side (Holman et al., 2019)
- Infants at eight months old can sit unsupported (Holman et al., 2019)

Topic: Baby-Friendly Care: Evaluating Client Understanding of Infant Care

- Parent-infant bonding behaviors include considering the infant as a member of the family (Holman et al., 2019)
- Behaviors that indicate no parent-infant bonding include handling the infant roughly and ignoring the infant's cry (Holman et al., 2019)
- Nurses facilitate bonding by placing the infant on the mother's skin right after birth (Holman et al., 2019)

Main Category #4: Psychosocial Integrity

Subcategory: Crisis Intervention

Topic: Crisis Management: Priority Actions During a Situational Crisis

- The nurse's priority is providing a sense of safety and protecting the client from potential harm (Holman et al., 2019)
- The nurse must identify the current problem causing distress to the client and initiate interventions (Holman et al., 2019)
- The nurse remains with the client during the crisis to deescalate the client's anxiety (Holman et al., 2019)

Topic: Trauma and Stressor Related Disorders: Making a Referral to Assess for Post Traumatic Stress Disorder

- PTSD is the exposure to a traumatic event to a client resulting in anxiety for longer than one month (Holman et al., 2019)
- Clients suffering from PTSD experiences flashbacks where the traumatic event recurs (Holman et al., 2019)
- For a client with PTSD, expected findings include avoidance of people, places, or events that bring back memories of the traumatic event (Holman et al., 2019)

Topic: Neurocognitive Disorders: Documenting Dementia Findings

- The onset of dementia is gradual, involving deterioration of the client's ability to function over months or years (Holman et al., 2019)
- Dementia level of consciousness does not change (Holman et al., 2019)
- Dementia involves restlessness and agitation, with sundowning often occurring (Holman et al., 2019)

Subcategory: Assistive Devices

Topic: Sensory Perception: Caring for a Client Who has Vision Loss

- The nurse calls the client by name to avoid startling the client when approaching them (Holman et al., 2019)
- The nurse identifies themselves to avoid confusion and respect the client (Holman et al., 2019)
- The nurse explains all interventions and tests to the client prior to touching the client (Holman et al., 2019)

Topic: Parkinson's Disease: Assessing a Client's Need for Physical Therapy

- The nurse notes that the client develops a slow shuffling gait (Holman et al., 2019)
- The nurse notes the client's muscles have become rigid and, to prevent a decrease in mobility, refers the client for physical therapy (Holman et al., 2019)
- Parkinson's disease will develop, making activities of daily living more complex, and physical therapy will slow the process down (Holman et al., 2019)

Topic: Osteoarthritis and Low Back Pain: Evaluating Client Understanding of Alternative Therapies

- Topical capsaicin is an alternative therapy to reduce pain, and the client must wear gloves when applying the cream (Holman et al., 2019)
- Glucosamine supplement reduces inflammation to relieve pain (Holman et al., 2019)
- Chondroitin supplements strengthen the cartilage to relieve back pain (Holman et al., 2019)

Subcategory: Nutrition and Oral Hydration

Topic: Fluid Imbalances: Findings to Report

- Dehydrated clients' vital signs show hypothermia, tachycardia, thready pulse, hypotension, tachypnea, and hypoxia (Holman et al., 2019)
- Clients overhydrated have vital signs showing tachycardia, bounding pulses, hypertension, tachypnea, and confusion (Holman et al., 2019)
- Clients who overhydrate will have decreased hematocrit, and clients who dehydrated will have increased hematocrit (Holman et al., 2019)

Topic: Home Safety: Providing Home Safety Teaching

- Keep emergency numbers located by a phone that is easily accessible to all household members (Holman et al., 2019)
- Remove items in an older adult's home that has the potential to cause injury, such as rugs and clutter (Holman et al., 2019)
- Teach preschoolers not to run with objects in their mouths to prevent choking (Holman et al., 2019)

Main Category #6: Pharmacological and Parenteral Therapies

Subcategory: Adverse Effects/Contraindications/Side Effects/Interactions

Topic: Medication for Depressive Disorders: Monitoring for Interactions Between Citalopram and St. John's Wort

- Taking Citalopram and St. John's Wort puts the client at risk for serotonin syndrome (Holman et al., 2019)
- The nurse assesses the client for symptoms of confusion, hallucinations, and seizures (Holman et al., 2019)
- Immediate notification to the primary provider is vital to prevent coma and death (Holman et al., 2019)

Topic: Therapeutic Procedures to Assist with Labor and Delivery: Identifying a Contraindication to Oxytocin Administration

- Oxytocin is not applicable used when the laboring client has frequent contractions lasting longer than ninety seconds (Holman et al., 2019)
- Oxytocin is not applicable used when the fetal heart rate is abnormal with no known cause (Holman et al., 2019)
- Oxytocin is not applicable used when the laboring client has no relaxation of the uterus between contractions (Holman et al., 2019)

Subcategory: Blood and Blood Products

Topic: Blood and Blood Product Transfusions: Intervention for Adverse Transfusion Reaction

- The primary action of the nurse is to stop the transfusion (Holman et al., 2019)
- The nurse removes the blood tubing and sends the blood bag and administration set to the lab (Holman et al., 2019)

- The nurse infuses normal saline with all new tubing and monitors the clients' vital signs (Holman et al., 2019)

Topic: Diabetes Mellitus: Reviewing Formulary About NPH Insulin

- NPH insulin is known as intermediate-acting insulin (Holman et al., 2019)
- NPH onset is one to two hours (Holman et al., 2019)
- NPH peak is four to fourteen hours (Holman et al., 2019)

Subcategory: Medication Administration

Topic: Multiple Sclerosis: Anticipated Prescription for the Provider to Prescribe

- Corticosteroids prescription helps reduce inflammation and informs the client of the increased risk of infection (Holman et al., 2019)
- Antispasmodics, including diazepam, baclofen, and tizanidine, treat muscle spasticity and instructed to report weakness that increases (Holman et al., 2019)
- Propranolol and clonazepam are beta blockers prescribed for the treatment of ataxia (Holman et al., 2019)

Topic: Pharmacokinetics and Routes of Administration: Intradermal Injection

- Do not massage the injection site after administration (Holman et al., 2019)
- Intradermal injections are for TB tests and allergy tests (Holman et al., 2019)
- Twenty-six to twenty-seven gauge needles to inject small amounts of solution at a ten to fifteen-degree angle (Holman et al., 2019)

- Do not use a tourniquet; instead, use a blood pressure cuff (Holman et al., 2019)

- Do not perform hard friction on the skin when cleaning the site (Holman et al., 2019)

Topic: Connective Tissue Disorders: Pain Medication for Fibromyalgia

- SNRIs such as duloxetine restore neurotransmitters, serotonin, and norepinephrine (Holman et al., 2019)
- GABA medication, pregabalin, is used to treat fibromyalgia (Holman et al., 2019)

- Instruct the client to change positions slowly while taking SNRIs (Holman et al., 2019)

Topic: Nonopioid Analgesics: Pain Medication for a Client Who has Cholelithiasis

- Prescribed NSAIDs to reduce inflammation and relieve pain (Holman et al., 2019)
- NSAIDs increase the risk of gastrointestinal discomforts such as nausea and heartburn and instruct the client to take the medication with food (Holman et al., 2019)
- Older adult clients taking NSAIDs must use caution due to adverse kidney function effects and instructed client to monitor intake and output (Holman et al., 2019)

Subcategory: Diagnostic Tests

Topic: Coagulation Disorders: expected Laboratory Test for a Client who has Petechiae and Ecchymoses

- Client presenting with petechiae and ecchymoses will have a hemoglobin lab test done due to potential DIC or ITP (Holman et al., 2019)
- Normal Reference range for Platelet levels is 150,000 to 400,000/mm³ (Holman et al., 2019)
- The client is at risk of DIC, resulting in fibrinogen-level lab tests with an expected reference range of 200 to 400 mg/dL (Holman et al., 2019)

Topic: Postoperative Care: Caring for a Client Who Has Delayed Wound Healing

- Instruct the client to eat foods high in calories, protein, and vitamin C to promote wound healing (Holman et al., 2019)
- Maintaining glycemic control for diabetic clients reduces the delay of wound healing (Holman et al., 2019)
- Older adult clients run the risk of delayed wound healing due to poor nutritional content (Holman et al., 2019)

Topic: Amputations: Evaluating Teaching

- Teach a client with phantom pain to push the affected limb down into the bed or perform quad sets (Holman et al., 2019)
- Educate the client to lie prone for twenty to thirty minutes throughout the day to prevent contractures (Holman et al., 2019)
- Educate the client on the process of grief, and it is customary to grieve for the loss of a limb (Holman et al., 2019)

Topic: Arthroplasty: Planning to Position a Client Following Total Hip Arthroplasty

- Ensure the client receives early ambulation post-procedure and transfer to a bed (Holman et al., 2019)
- Do not internally rotate the surgical leg (Holman et al., 2019)
- Use an abduction pillow while lying in bed and avoid flexion of the hip greater than ninety degrees

Subcategory: Alterations in Body Systems

Topic: Cancer and Immunosuppression Disorders: Teaching a Client who is Undergoing Radiation Therapy

- Do not eat before radiation therapy if the client presents with nausea or vomiting (Holman et al., 2019)
- Instruct the client to avoid fatty or fried foods and limit caffeine to prevent diarrhea (Holman et al., 2019)
- Instruct the client to eat small frequent meals high in calories and protein (Holman et al., 2019)

Topic: Electrolyte Imbalances: Assessing a Client who is Immediately Postoperative Following a Subtotal Thyroidectomy

- Assessment of the client's calcium level due to potential hypocalcemia (Holman et al., 2019)
- The potassium reference range is 3.5 to 5.0 (Holman et al., 2019)
- The calcium reference range is 9.0 to 10.5 (Holman et al., 2019)

Topic: Acute and Chronic Gastritis: Performing Gastric Lavage

- Insert an NG tube to perform a gastric lavage (Holman et al., 2019)
- Gastric lavage involves irrigating with normal saline or water to stop gastric bleeding (Holman et al., 2019)
- Prevent aspiration from irrigation; a chest x-ray verifies NG tube placement (Holman et al., 2019)

- Respiratory status presents with coughing, tachypnea, dyspnea, wheezing, and retractions (Holman et al., 2019)

Topic: Fluid Imbalances: Interpreting Laboratory Results

- The hypovolemic client presents increased BUN and a specific gravity greater than 1.030 (Holman et al., 2019)
- Overhydrated client presents with decreased Hct and Hgb (Holman et al., 2019)
- Decreased BUN, urine sodium, and specific gravity represent an overhydrated client (Holman et al., 2019)

Topic: Hepatitis and Cirrhosis: Monitoring for Fluid Volume Excess

- Monitor a client with cirrhosis for fluid volume excess in the presentation of ascites (Holman et al., 2019)
- Assessment of fluid volume excess by jugular vein distention and peripheral edema (Holman et al., 2019)
- Clients with fluid volume excess must restrict sodium in their diet (Holman et al., 2019)
