<b>Question 2</b>	Dr. Craig's response to Sarah demonstrated a form of workplace violence. Which of the following behaviors are also considered incivility in the workplace?	
<b>Selected Option/ Result</b>	Eye rolling	<b>Result:</b> Correct
<b>Rationale</b>	Non-verbal disruptive behaviors such as eye rolling, constant eye contact, and personal space invasion are hurtful and threatening. They are considered incivility or workplace violence.

<b>Selected Option/ Result</b>	A client who is receiving treatment for depression in an inpatient setting commits suicide.	<b>Result:</b> Correct
<b>Rationale</b>	A sentinel event is an occurrence that is unexpected and involves death or serious injury; therefore, this situation describes a sentinel event.	
<b>Question 4</b>	Beverly informed Sarah that Mr. Adam's fall was not considered a sentinel event. What qualifying circumstances would have made the fall a sentinel event?	
<b>Selected Option/ Result</b>	Mr. Adams was severely injured when he fell.	<b>Result:</b> Correct
<b>Rationale</b>	If an incident occurs which results in a severe temporary or permanent injury or death, it is considered a sentinel event. This type of event requires an immediate investigation and response.	
<b>Stage 3 (2 of 2 Correct)</b>		
<b>Question 1</b>	Sarah informs Beverly that she makes a careful analysis of the situation prior to accepting an assignment to float. Which of the following actions should Sarah take first when making the decision to accept or reject an assignment?	
<b>Selected Option/ Result</b>	Request specific information about the assignment.	<b>Result:</b> Correct
<b>Rationale</b>	Before the nurse can decide to accept or reject the assignment, the nurse needs to have specific information regarding the clients and the care she will provide. Therefore, based on the nursing process priority-setting framework, collecting information about the assignment is the first action the nurse should take.	
<b>Question 2</b>	Beverly is discussing with Sarah clients that she would consider herself capable of caring for should she float to the unit again. Which of the following assignments is the most appropriate for Sarah?	

<b>Selected Option/ Result</b>	A client who has anemia and is receiving a blood transfusion	<b>Result: Correct</b>
<b>Rationale</b>	This client is receiving a treatment that the nurse would usually perform on an obstetric unit. Therefore, this is the most appropriate assignment.	
<b>Stage 4 (1 of 1 Correct)</b>		
<b>Question 1</b>	Beverly reviews Nicki's personnel file and determines that there is no documentation that Nicki previously had been reported for neglecting her duties. When using a progressive discipline process, which of the following actions should Beverly plan to take?	
<b>Selected Option/ Result</b>	Meet with Nicki to discuss an informal reprimand.	<b>Result: Correct</b>
<b>Rationale</b>	Nicki's actions of not performing hourly rounding and leaving the unit without notifying Sarah contributed to Mr. Adams's fall. Nicki should be counseled that this behavior impacted client safety. Because there is no documentation of this type of behavior occurring previously, it would be appropriate to provide Nicki with a verbal warning/informal reprimand.

<b>Rationale</b>	This client will require discharge teaching that the nurse may not be prepared to provide. With the proper training and supervision, the nurse could care for this client, but it is not the most appropriate assignment.
