### Overview

Prayer is vital to our general health and well-being, and I am thrilled to see what the Lord is doing in this season. God is moving tremendously in the lives of his people, and I am blessed to be a part of move of God.

### Prayer Case 1

On Sunday April 9, 2023, I met with David, from 5pm to 5:30 pm for half an hour. David reported feeling better, but continues to request prayers for his ex-girlfriend, who is dealing with more than one loss in her life.

### Prayer Case 2

On Sunday April 23, 2023, at 1:00pm I met with Anna for 45 minutes, she had requested prayers because she was tormented by demonic forces in her home. Anna said she was unable to

sleep at night and felt heaviness rested on her body. She complained that shadows were moving in her home, disturbing her peace. I invited the Holy Spirit to be in our midst to heal and deliver, I prayed that the prince of peace will be her portion. During the interview, I asked Anna if she was fearful of the things she was experiencing. She responded that she was so afraid that she plays her radio on the gospel radio station around the clock, every day. I spoke to Anna about the power that is in the authority in the word of God and love he has bestowed upon us. I shared Luke 10:19 with her and prayed that the Lord will open her spiritual eyes to see that our God is greater, and he has given us authority over all the power of the enemy. As I began to pray the lord led me to destroy every stronghold of the mind. Anna left rejoicing, she went on vacation feeling great and is looking forward to another meeting.

### Prayer Case 3

Sunday April 23, 2023, I met with Sue for 30 mins from 5pm to 5:30pm. During the interview, Sue disclosed that she was concerned because her boss told her he would no longer need her services. We invited the Holy Spirit to take control of the situation, and asked God for favor. I asked Sue if there was anything else needed God to do and she asked for prayers for her family. Again, we invited the Lord in our midst and prayed that the Lord would bless her and family. I prayed God's favor for her to receive a job offer speedily according to God's plan and purpose for her life. She is waiting on the Lord to come through for her, while she continues to search.

### Prayer Case 4

On Sunday April 30, 2023, I met with Don for 30 minutes from 1:00pm to 1:30pm. We prayed before the interview and asked God to intervene in the meeting to help us. I asked Don

what he would like God to do for him, and he requested prayers for himself and Fiancé. They are planning to get married soon and want the Lord to guide them in their decision making. As I began to pray heard the Lord told me to unravel the chord that had bound him from his head all the way down. When I was through, Don started shouting and screaming “I am free! I am free! I asked him what happened, he told me that years ago his mom told him that she almost lost him during his birth. She told him that the Doctors told her that the umbilical cord was wrapped tightly around his body and delivery was exceedingly difficult. He claimed that he has experienced limitations and obstacles in life. While I was praying and unraveling the cord from around him, he said the Lord reminded him of what his mom told him and told him that today he had been set free. I blessed Don, his fiancé, and their upcoming marriage, and prayed that the Lord would keep them.

#### Prayer Case 5

I met with Tavy for 30 minutes from 5:00 pm to 5:30pm on Sunday April 30, 2023. During the interview, I asked Tavy if there was anything she would like the Lord to do for her. And she said pray for whatever the Lord lays on your heart. I started praising God for who he is, glorifying his name and thanking him for his goodness and mercy towards us.
