1. What does "normalcy" mean? state of being normal, usual, or expected.

2. Fill in the blanks: Developmentally appropriate activities are based on a child's Cognitive, emotional and physical capacities that are typical for an age or age group.

3. What are 3 factors to consider when applying the Prudent Parenting standard to parenting decisions? Childs age, maturity & developmental level. Risk of activity. Best interest of the child.

4. TRUE or FALSE - Caregivers demonstrating compliance with the Prudent Parent Standard will not incur civil liability if foster child is harmed or injured while participating in an approved activity.
