2. Information about Covid-19 can change frequently. This plan was created under the guidance of the DHS and MN Department of Health Washing
3. The best way to prevent the spread of illness is Hand sanitizer. If soap and water are not available, an alternative is the use of hand sanitizer.
4. I am expected to wear a Face Mask while I am at a Beacon program. Cleaning check list
5. I know that I will be cleaning well, and cleaning often. I will follow a Beacon log that identifies surfaces and areas that have been disinfected. I will ensure cleaning products remain in surface contact for at least 5 minutes to ensure organisms are killed.
6. Before entering a Beacon program or office, I am expected to face mask self screen myself for symptoms, and to take my temperature. If my temperature is over 100.0 degrees, I will not enter. My doctor MNDH
7. If I have symptoms of Covid-19, I should contact MNDH and follow instructions regarding care and testing.
8. Part of my job includes monitoring the people we support for Sign and Symptoms of Covid-19.
9. Essential visitors are allowed in a Beacon program of office as long as they are performing an essential function.
10. Social Distancing includes remaining 6 feet in distance from others. It also includes avoiding human contact with others. Facing same direction
11. We might need to move furniture or chairs so people are facing the 6 feet instead of toward each other.
12. When cooking, 1 staff should be in the kitchen preparing the meal.
13. Sharing of food, plates, and utensils should be avoided.
14. Opening windows introduces fresh air. We should do this as often as possible remembering also that we should Not be creating airflow which blows Across people from one person to another. before
15. When providing transportation, vehicles will be sanitized clean and After each ride. I also should remember that I need to limit the number of people in a vehicle at one time.
