## Individual Abuse Prevention Plan (IAPP)

### Instructions and requirements:

This program is required to establish and enforce ongoing written individual abuse prevention plans as required under Minnesota Statutes, section [626.557](#), subdivision 14 and section [245A.65](#), subdivision 2 (b).

Development and review of the plan: An individual abuse prevention plan shall be developed for each new person as part of the initial individual program plan or service plan required under the applicable licensing rule. The review and evaluation of the individual abuse prevention plan shall be done as part of the review of the program plan or service plan. The person receiving services shall participate in the development of the individual abuse prevention plan to the full extent of the person's abilities. If applicable, the person's legal representative shall be given the opportunity to participate with or for the person in the development of the plan. The interdisciplinary team shall document the review of all abuse prevention plans at least annually, using the individual assessment and any reports of abuse relating to the person. The plan shall be revised to reflect the results of this review.

Plan contents: The plan shall include a statement of measures that will be taken to minimize the risk of abuse to the vulnerable adult when the individual assessment required in section 626.557, subdivision 14, paragraph (b), indicates the need for measures in addition to the specific measures identified in the program abuse prevention plan. The measures shall include the specific actions the program will take to minimize the risk of abuse within the scope of the licensed services, and will identify referrals made when the vulnerable adult is susceptible to abuse outside the scope or control of the licensed services. When the assessment indicates that the vulnerable adult does not need specific risk reduction measures in addition to those identified in the program abuse prevention plan, the individual abuse prevention plan shall document this determination.

Requirements of [626.557](#), subd. 14(b): Each facility, including a home health care agency and personal care attendant services providers, shall develop an individual abuse prevention plan for each vulnerable adult residing there or receiving services from them. The plan shall contain an individualized assessment of: (1) the person's susceptibility to abuse by other individuals, including other vulnerable adults; (2) the person's risk of abusing other vulnerable adults; and (3) statements of the specific measures to be taken to minimize the risk of abuse to that person and other vulnerable adults. For the purposes of this paragraph, the term "abuse" includes self-abuse.

Persons with history of violent crime an act of physical aggression toward others: If the program knows that the vulnerable adult has committed a violent crime or an act of physical aggression toward others, the individual abuse prevention plan must detail the measures to be taken to minimize the risk that the vulnerable adult might reasonably be expected to pose to visitors to the facility and persons outside the facility, if unsupervised. Under this section, a facility knows of a vulnerable adult's history of criminal misconduct or physical aggression if it receives such information from a law enforcement authority or through a medical record prepared by another facility, another health care provider, or the facility's ongoing assessments of the vulnerable adult.

## Individual Abuse Prevention Plan (IAPP)

### A. Sexual abuse

#### Specific measures to minimize risk of abuse for each area checked:

- Karen has a limited understanding of sexuality. Karen knows when someone has touched her inappropriately and has accurately reported this in the past. If the perpetrator was a trusted individual, Karen may not recognize the situation as abuse.
- Karen is not likely to seek out an abusive situation, but may participate if the perpetrator was a trusted person and Karen did not recognize the situation as abuse.
- Karen is unable to be assertive in some situations. Karen is usually a good advocate for herself and can verbalize what she does and not does consent to, however Karen may be intimidated to not report abuse if the perpetrator was a trusted person or if Karen did not recognize the situation as abuse.
- **All Areas:** Karen will be encouraged to participate in social skills classes available at PAI to work on appropriate boundaries and relationships with others. If staff ever found or suspected that Karen was in an abusive situation, staff would remove Karen from the situation immediately and relocate her to a safe location. Staff would notify Karen's guardian and residence and help Karen make a report or contact the authorities if necessary. All staff at PAI are mandated reporters. Staff are trained at time of hire on mandated reporting and annually thereafter. Staff are always with Karen in the community and at PAI and will help Karen advocate on her behalf. Staff will have discussions with Karen following any situations where Karen was unable to be assertive with others and review and role play ways Karen can advocate for herself.

**Referrals made when the person is susceptible to abuse outside the scope or control of this program (Identify the referral and the date it occurred).** No referrals needed at this time.

## B. Physical Abuse

Is the person susceptible to abuse in this area?  Yes (if any area below is checked)  No

- Inability to identify potentially dangerous situations
- Lack of community orientation skills
- Inappropriate interactions with others

### Specific measures to minimize risk of abuse for each area checked:

- Karen is unable to identify potentially dangerous situations in all cases. Karen is usually very aware of her surroundings, however can become distracted. Karen is a very trusting person and may not recognize that a stranger could be dangerous.
- Karen lacks community orientation skills. Karen would likely not know how to get home if left alone in the community. Karen would ask for help, but Karen is a very trusting individual and may not know who to trust for help.
- Karen is unable to deal with verbally/physically aggressive persons. Karen would not know how to respond in this situation and would likely not be able to physically defend herself. Karen may need help leaving the area.
- **All Areas:** Karen participates in fire and storm drills at PAI to practice how to react in an emergency situation. Staff will always be with Karen in the community and will advocate on Karen's behalf. Staff will model safe pedestrian skills and stranger safety and prompt Karen as needed to follow these. If Karen was in a situation at PAI involving verbally/physically aggressive persons, whether it be at PAI or in the community, staff would intervene and remove Karen from the situation. Staff would talk to Karen 1:1 about how she was feeling and make sure she felt and was safe before returning to what she was doing.

**Referrals made when the person is susceptible to abuse outside the scope or control of this program (Identify the referral and the date it occurred).** No referrals needed at this time.

## C. Self Abuse

## Specific measures to minimize risk of abuse for each area checked:

- Karen may lack self-preservation skills in some areas. Karen is usually observant of her surroundings, but can become distracted. Karen may need help knowing how to respond in an emergency situation if she was somewhere unfamiliar.
- **All Areas:** Staff are always with Karen in the community and at PAI and will advocate on Karen's behalf, prompting her to follow safety rules when needed. Karen participates in fire and storm drills at PAI.

**Referrals made when the person is susceptible to abuse outside the scope or control of this program (Identify the referral and the date it occurred).** No referrals needed at this time.

## D. Financial Exploitation

## Specific measures to minimize risk of abuse for each area checked:

- Karen is unable to handle financial matters independently. When Karen is going to participate in a community outing that requires cash, a funds request form will be sent home with Karen a few days prior to the outing. Karen will bring cash in with her that day and keep it with her the duration of the day.
- **All Areas:** Staff will help Karen make the transaction, ensure she has gotten a receipt and correct change, and help Karen secure the change back with her belongings. Karen's residence helps Karen manage and track her finances at home.
