3. **List and explain a procedure(s) you observed performed by a technologist in each clinical area (Two procedures from diagnostic in ED/Outpatient/Main; one procedure from fluoroscopy; one procedure from CT; one procedure from MRI). Your description must include the following topics:**
 - a. Any additional tool(s) required to perform the exam or procedure
 - b. Position(s) patient was placed in for imaging
 - c. Safety concerns associated with the exam or procedure for both the technologist and the patient
 - d. Any preparation required by the patient prior to the exam (i.e., medications administered, fasting required, no specific preparation required, etc.)
 - e. Any additional steps to the procedural routine (i.e. additional safety steps, informed consent, etc.)

- 9. Provide two behaviors you observed in a technologist that you wish to emulate to contribute to a positive patient experience? Explain.**
- 10. Provide two behaviors you observed that you perceived as poor practice and detrimental to the patient experience? Explain.**
- 11. Identify 6 or more ways in which you could assist a technologist as a student within the clinical environment to contribute to teamwork in regards to the flow of procedures and overall patient flow? (this can include but is not limited to items within the room, prior to patient arrival, during the procedure, after the patient is dismissed, etc.)**
- 12. Describe one thing you learned during your clinical experience this semester that surprised you personally. (i.e. challenges you were not aware of, physical impact of being a technologist such as common injuries or physical challenges, patient preparation requirements, etc.)**
